Defense of Marriage Act Struck Down by U.S. Supreme Court: What now for the liberty movement?

June 26, 2013, the Supreme Court struck down an act, passed by Congress, and signed by President Clinton, called the Defense of Marriage Act. The Act did a number of things, but two of those things in particular stand out as important. Section 2 of the Act established that no state shall be required to give effect (or full faith and credit, as it is termed in the Constitution) to same-sex marriages performed in a different state. Section 3 of the Act established that the federal government *would not* recognize same sex marriages for any purpose. The decision that was issued today pertains only to Section 3.

First of all, congratulations are in order. Any move away from giving government credence as the arbiter of morality ought to be welcomed - as this decision surely is. Render unto Caesar the things that are Caesar's, and unto God, the things that are God's. Folks ought to be allowed to fervently believe, and tell it from the rooftops, that gay marriage is immoral, unnatural, or sinful. But government is not the proper body to determine what is good and evil on such issues of conscience. So to the extent that this decision takes some authority away from the federal government to tell the rest of us what is and is not moral, the decision ought to be celebrated.

What is fascinating about the decision, from a legal perspective, is more what was explicitly not decided than what was decided. First, the background: The Plaintiff in this matter claimed that she was being denied a refund of her federal estate taxes that would have otherwise been due to a surviving spouse. The Plaintiff had been married to the decedent under New York law, and her refund therefore would have been an uncomplicated matter but for the fact that the decedent, her spouse, was also a woman.

The Court began its discussion of the merits of the case by recognizing that:

"It seems fair to conclude that, until recent years, many citizens had not even considered the possibility that two persons of the same sex might aspire to occupy the same status and dignity as that of a man and woman in lawful marriage. For marriage between a man and a woman no doubt had been thought of by most people as essential to the very definition of that term and to its role and function throughout the history of civilization. That belief, for many who long have held it, became even more urgent, more cherished when challenged. For others, however, came the beginnings of a new perspective, a new insight." The Court made sure to clarify, with this as a backdrop, that its decision was not based upon concerns of federalism meaning that the Court did not hold that the definition of marriage was a question better left to state governments. It explicitly held that the federal government does have the authority to regulate marriage to some extent. That principle is limited, however. The question of what constitutes a marriage traditionally is left to the states. For example, as the Court pointed out "the required minimum age is 16 in Vermont, but only 13 in New Hampshire." Instead of relying on principles of federalism, the Court noted that:

"Here the State's decision to give this class of persons the right to marry conferred upon them a dignity and status of immense import. When the State used its historic and essential authority to define the marital relation in this way, its role and its power in making the decision enhanced the recognition, dignity, and protection of the class in their own community. DOMA, because of its reach and extent, departs from this history and tradition of reliance on state law to define marriage."

In other words, it isn't that the state has the sole power to determine the definition of a married couple that compelled the striking of DOMA. It's the fact that the state of New York created a class of people, same-sex married couples, by conferring upon them the right to marry. That class, therefore, deserves protection, because "discriminations of an unusual character especially suggest careful consideration to determine whether they are obnoxious to the constitutional provision." The question that the Court, therefore, had to answer was whether DOMA violated the equal protection clause of the Fifth Amendment to the Constitution.

In the view of the Court, the status of a married couple conferred upon same sex married couples by New York law "is a far-reaching legal acknowledgment of the intimate relationship between two people, a relationship deemed by the State worthy of dignity in the community equal with all other marriages."

Since New York had deemed these couples worthy of protection, the federal government had violated "basic due process and equal protection principles" codified in the Constitution's Fifth Amendment by seeking to injure that very class that had been given New York's protection. It was the fact that New York had deemed these marriages lawful that rendered suspect the federal government's refusal to recognize them as such. In other words, there is no inherent protection given to gay couples. If the State of New York had recognized marriages between three or more people, ostensibly, the Supreme Court would have deemed those marriages worthy of federal respect for no reason other than the fact that the State of New York had given them sanction. "DOMA's principal effect is to identify a subset of state sanctioned marriages and make them unequal," the Court reasoned.

By creating two contradictory marriage regimes within the same State, DOMA forces same-sex couples to live as married for the purpose of state law but unmarried for the purpose of federal law, thus diminishing the stability and predictability of basic personal relations the State has found it proper to acknowledge and protect.

Clearly, this country has come a long way since 1996, when this bill was signed into law by someone who had been identified by social conservatives as being this great country's most liberal president. Even President Obama has "evolved" (his words, not mine) on this issue. But clearly, this country has a long way to go before it recognizes that government truly is not the solution to the problem of perceived immorality. Questions of conscience ought to be left up to each individual, in consultation with the religious or civil leader of one's choice, or made in the hollows of each individual's heart.

I congratulate the victors in this important Supreme Court decision, and I look forward to the day when true marriage equality is the law of the land in all 50 states.

Judicial Reception to be Held Tuesday, December 17, 2013

One of the most popular Decalogue events – and a personal favorite of mine – is the Annual Judicial Reception. Many bar organizations hold their judicial receptions in posh banquet halls where they serve fancy food. Sometimes, people even wear tuxedos. What really sets Decalogue's Judicial Reception apart is the fact that we don't do any of that.

Decalogue's Judicial Reception holds a special place in the hearts of many judges -- especially those who may not be Jewish. The popularity of our judicial reception, based on numerous anecdotal reports received by Decalogue members over many years, is simple: ours is the only event where the judges can be assured that instead of the usual chicken of questionable texture and quality, there will be kosher hot dogs.

When I first became involved with Decalogue Society, a surprising number of judges made a point of telling me how much they look forward to the kosher hot dogs at our judicial reception. These conversations were "sua sponte" -- which is Latin for "Michael, I would rather talk about kosher hot dogs than your boring brief." Still, the point was made.

For years, we held the judicial reception in the basement of Loop Synagogue. However, the popularity of the event outgrew the available space. In recent years, Decalogue has held the event at the Crowne Plaza Chicago Metro, 733 W. Madison, Chicago. The facility is a little off the beaten path, and the room is conducive to chatting with our fine local judiciary in a decidedly un-stuffy setting. The location is considered a blessing to the many Cook County judges who do not have assignments in the Chicago loop. As result, this event tends to draw more judges from the criminal, juvenile and some outlying districts, in addition to the usual complement of judges from the Daley Center.

Although there are those who would insist that failure to consume a hot dog at this event is a breach of tradition, rest assured that hamburgers, soft pretzels, and "assorted fresh garden vegetables presented with gourmet crackers and hummus" are available, along with cookies and brownies. No need for concern that you will be tucked away at a table at an unsettling distance from any actual judges -- technically, we do not actually have tables. There are chairs, but people tend to mill about.

The event programming is straightforward. Decalogue President Jim Goldberg will thank the judges, sponsors and other guests. After that, there are no speeches. This is because, within a matter of minutes, no one will be able to hear anything anyway.


